- **4-28-22:** The required Map Validation field in the MLS is integral to ensuring listings are mapped properly and the correct listing location is displayed. While a geocode is automatically assigned to a listing, sometimes the auto-assigned geocode can be placed incorrectly and the property location pin needs to be manually updated to the proper location.

- 6-2-22: NAR Policy 8.5 Non-filtering of Listings was mandated to prohibit the ability to filter out or restrict MLS listings based on the level of compensation offered to the cooperating broker or by the name of a brokerage or agent.

All listing status changes are required to be recorded in the MLS within two days after they've occurred, with the exception of the final closing of sales. The final closing of sales must be recorded within five days after they have occurred. Be sure to check your listings to ensure they are in the correct status!
