All current MLS payments for MLS service have been discontinued.

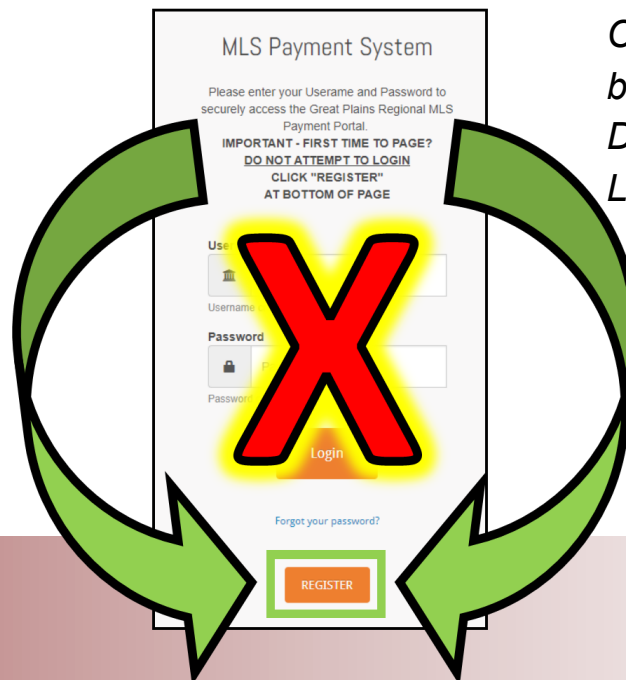


All MLS users* are required to register a payment account and authorize MLS fees before March 31, to avoid an interruption of MLS service.

** If your account will be paid by another user, STOP here. Check with that individual to make certain they have included your payment with their authorization—failure to authorize MLS fees will result in service suspension.*

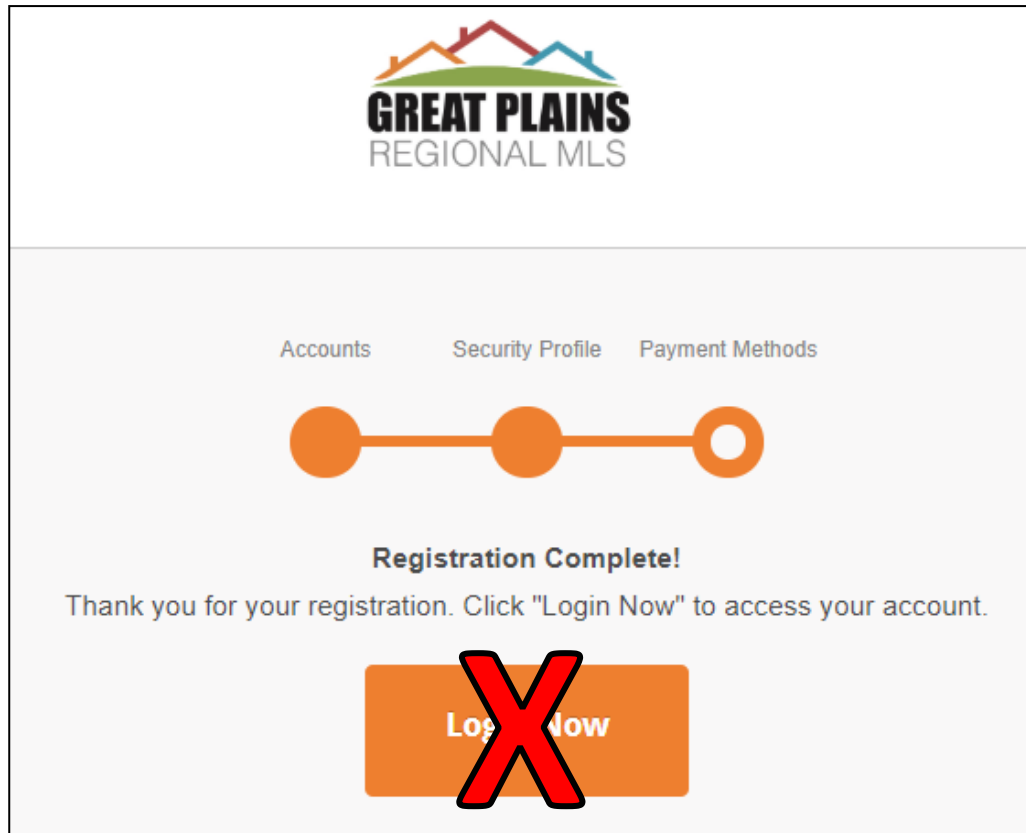
