February 2019



- **2-27-19:** Updates were deployed to the Paragon MLS Tuesday, February 26. [Release notes \(PDF\)](#)
- **2-20-19:** Important Dates (GPRMLS LLC):
  - 2-25-19 to 3-22-19: MMLS data available in Paragon.
  - Rapattoni MLS users continue to input and maintain listings in Rapattoni MLS
  - Data is updated every hour or two in Paragon
  - Users may notice some duplicate listings if listings were added in both systems. The duplicates will be removed before the final conversion on March 25.
  - Users should cancel any duplicate listings for the MLS account that is not their primary account.
  - Users with accounts in Paragon and Rapattoni will continue to have two accounts until 3/25
  - (MMLS Users will keep their Rapattoni MLS ID appended with and 'L'. GPRMLS Inc. Users will keep their Paragon MLS ID unless they let staff know otherwise.)
    - 3-22-19: Rapattoni MLS is switched to 'read-only'.
    - 3-22-19 - 3-24-19: Rapattoni MLS users will not be able to input or maintain any listings during this time.
      - Be sure to input and update all listings by end of day, Thursday, 3/21/19.
    - 3-25-19 Conversion is complete.  
All users enter and maintain listings in Paragon MLS.

March 2019



- 3-29-19: The MLS will be unavailable for listing maintenance and input from 7:00 pm - 6:00 am on Monday, April 1 for scheduled maintenance.
- 3-25-19: DEADLINE – All MLS Users need to set up a New User Account before March 31. If you have not already done so this month, your MLS service will be suspended. Unfortunately, there is no weekend support for this payment setup, so please start the process today (5 easy steps) <https://www.gprmls.com/reauthorize>
- 3-15-19: Statistics – Duplicate listings and agents are in the process of being removed from Paragon. As a result, February and March stats will not be produced until the new tools from MarketStats are implemented in four to six weeks. We apologize for the inconvenience. The new MarketStats implementation will make two new tools available:
  - FastStats – monthly reports for Lincoln, Omaha, and the entire region. These will be produced and available on the MLS website: <https://www.GPRMLS.com>.
  - InfoSparks – all users will have the ability to create custom-branded, on-the-fly statistical reports for various criteria.
- 3-14-19: Map searches for Lincoln users – (RESOLVED) There is a known issue with the geocodes for mapping as they come over from the Rapattoni MLS system to the Paragon MLS system. For now, Lincoln map searches will not return the desired results. Black Knight has developed a solution which will be implemented beginning Monday 3-18-19 at 7:00 p.m. Until Tuesday, we recommend you use other criteria for your searches (zip codes, schools, subdivision, etc.).
- 3-13-19: All current MLS payments have been discontinued. The new regional MLS is utilizing an automated account system. All MLS users must register and reauthorize their MLS fee payments by March 31, to avoid a service interruption.
- The first step is to create your new account – be sure to follow the instructions on the initial page. First, click on the “Register Your MLS ID” button  
On the next page enter an account “Nickname” (your choice), your current MLS ID, and for verification the first two letters of your last name (in lower case). IMPORTANT: Scroll down, accept the terms, then click Next. Complete instructions (PDF)
- 3-4-19: It’s happening! On 2-25-19 the conversion and migration of data and photos from the Midlands MLS / Rapattoni MLS system in Lincoln began and are now visible in the Great Plains Regional MLS, LLC (GPRMLS) Paragon MLS system. [Read full update \(PDF\)](#)
